(1) *Ethnic Bargaining: The Paradox of Minority Empowerment*, Cornell University Press, 2007. (Winner of the 2007 *Edgar S. Furniss Book Award* for an exceptional contribution to the study of national and international security, Merhson Center for International Security Studies, The Ohio State University; 2007 *Choice* Outstanding Academic Title, *Choice Magazine*.) The book asks the question why minorities sometimes radicalize their demands against the central government in the absence of obvious economic incentives or security imperatives. Using field research conducted on seven minority groups in contemporary Czech Republic, Slovakia, Romania, and Serbia, and one group in interwar Czechoslovakia, the book demonstrates that, contrary to prevailing theories of ethnic conflict, minority leaders in Eastern Europe have played a relatively peripheral role in ethnic mobilization. The book also shows that minorities do not usually radicalize in response to fears of discrimination. They instead mobilize opportunistically in response to perceptions of external patronage that increase the expected value of rebellion over that of inter-ethnic compromise. The book is based on my Ph.D. dissertation, which received the *Seymour Martin Lipset Award for Best Comparative Dissertation of the Year*, 2001.
